- the person who owns or leases the vehicle must be age 65 or older, and

 the principal operator (the person driving your vehicle the majority of the time during the policy term) must be age 65 or older, and

- the vehicle is used for pleasure only (can't be used to drive to or from work)."

Riding B.C. ferries Is cheaper, you'll see Monday to Thursday With your new I.D.

At 65, get your new B.C. Service Card. Present it when riding B.C. Ferries, Monday to Thursday. As a passenger or walk-on, you pay half-price.

For credit courses At U.F.V.

You may now find They'll wave a fee.

Apply to be a student (pay the \$45). When you register for a credit course, you may now find that the course is free. (There are certain stipulations, especially if auditing a course, and acceptance may be limited to availability.) This does not apply to Continuing Ed. courses.

Look for Senior Discounts Wherever you go. You could save a lot If you're in the know.

Last August, I was asked if I would take a voluntary position as an assistant to the cello teacher at The Bakerview Music Academy. I have always wanted to be a bit more involved in our own community, so I said, "yes" to this wonderful opportunity.

Bakerview Music Academy is a non-profit, charitable society that provides FREE music programs for under privileged children. It has a board of directors, a program director, a team of professional-minded teachers and an extensive network of volunteers. BMA relies entirely on donations from individuals, local business and foundation to run its programs.

This school year, there are almost 70 children enrolled in the BMA music program.

The students attend the after school music program, twice a week from 3:00-5:00 at the Bakerview Church on Clearbrook Road. They start with a nutritious meal, followed by 40 minutes of choir, 40 minutes of percussion and 40 minutes of the instrument of their choice (piano, violin or cello). The future growth includes a string orchestra in September 2016.
