The BCRTA is living in interesting times! Our First Year Free Membership initiative has resulted in a significant BCRTA membership gain this year. Keep spreading the word.

In order to enhance membership growth, the Membership Committee is developing some BCRTA merchandise for distribution, and is looking at new ways to extend membership eligibility.

We are also exploring the possible merger of provincial and branch membership fees. This would mean a standard BCRTA fee that includes membership in one branch of choice. Members could join a second branch for an additional fee. It is hoped that this arrangement could be part of the First Year complimentary Membership offer. We are also looking at promoting a "pre-retirement associate membership" to help transition retiring teachers into

Green Shield Coverage Generates Questions From Members

The BCRTA office staff are spending quite a bit of time dealing with questions and issues around Green Shield Canada (GSC) – the Extended Health Benefit provider for members in the Teachers' Pension Plan. The move to Green Shield was a decision of the Teachers' Pension Board of Trustees - not the BCRTA. The decision was made following an open competition; other insurance companies were invited to submit proposals and GSC won the competition. The BCRTA plays no role in this as we have no direct contractual relationship with GSC.

Please share this information:

The GSC plan is like the former Blue Cross plan both in design and service. GSC has worked to ensure affordability by not increasing premiums this year and has also worked to be more precise, strict and consistent in interpreting the agreement and in accepting or denying claims.

What to Do If You Are Not Satisfied

If a problem occurs:

- **a)** Contact Green Shield directly and try to solve the problem with an agent of GSC.
- **b)** If not satisfied escalate your demands by asking to speak to a supervisor. To request an escalation in service call toll free 1-888-711-1119 Mon. to Fri. 5:30am to 5:30pm or email: customer.service@greenshield.ca.

Pension Committee Update

The committee made these recommendations that were passed by the Executive and are in process:

- Cooperate with COSCO by providing technical support in the development of a petition opposed to Bill C-27
- Hire an independent insurance consultant to review the financial reporting we receive from Johnson Insurance. We believe that we had had excellent service and reporting from Johnson's but as part of our due diligence we want to have an independent expert's confirmation as we move forward.
- A letter has been written to the MSP task force supporting the replacement of premiums with increases in personal income and business taxes.
- A letter has been sent to the Prime Minister, the Minister of Finance and the Minister of Health urging them to implement a national Pharmacare program.
- A letter was written to the National Pensioners Federation in support of its campaign to restrict aggressive sales practices by large telecom companies.
- We received a report from Dale Lauber, the Trustee that represents the retired members of the Teachers' Pension Plan. An actuarial report is currently underway and we can expect positive news when it is finished and made public around September 1.




Connections Feedback Invited

BCRTA Working to Support Well-being of Members and BC Seniors

The Well-Being committee will be providing four pages of articles for the spring edition of PostScript including one on the present disjointed BC Pharmacare program, one on senior recreation involving Pickle Ball, one on a personal experience showing the need for a will, and an article on the need to keep on top of eye health.

Is Bill C27 Still A Pension Threat?

Should the BCRTA still be concerned about <u>Bill</u> <u>C-27</u>? It had first reading on October 19, 2016 and lies apparently "dormant" in the federal legislative process. Some claim that the bill is "frozen" and poses no danger to us.

Yet, on November 1, 2017, when the NDP attempted to table a motion asking for the withdrawal of Bill C-27, the motion did not get enough support for consideration in the House of Commons. [1] On January 11 of this year (2018) the Pension Commission of Manitoba raised the possibility of allowing for target-benefit and shared risk plans; the subsequent consultation will address pension regulatory issues including whether the rules should "allow for converting future benefits accruals only". [2] In other words, there is no assurance that current employees and retirees would not be affected by changes. The central idea of Bill C27 is still very much alive in governments across Canada.

What We Believe

The BCRTA Pensions & Benefits Committee believes that we must continue to fight Bill C-27. It poses a threat to Canadians who have pension security. As a Committee member observed, "The intention for a law based on a bill such as Bill C-27 is not 'if' but 'when'.

What BCRTA is Doing

We have made a great start! The Board thanks all of you advocates who have actively opposed Bill C-27. Since our request for action last September, your feedback to Laurie in our office indicates that as of January 23, 2018 over 85 contacts have been made. In one case, about 10 constituents visited an MP, and in another 34 endorsed a letter to an MP. We estimate that about 115 BCRTA members have been in touch with MPs.

34 different MPs have been contacted, including the Prime Minister (7 written contacts), the Minister of Finance (one face-to-face contact, and 10 written contacts) and Robyn Benson, National President Public Service Alliance of Canada (1 email letter). You may see the list of contacts we have tracked, and get involved.

Contacts have included face-to-face visits, letters, email letters, and phone calls, including one to MP Carla Qualtrough, whose office indicated that other calls had been received.



An analysis of our website hits indicates that many visitors are looking at our documents related to Bill C-27. The visitors are from all over our province and as far away as Ottawa!

We hope you will continue your advocacy efforts on this important issue, and ask that you please urge your fellow branch members to keep up the pressure. Our goal is still 25 contacts for each MP and to contact the 16 MPs have not heard from us at all.

It has been pointed out to us that our written letters and emails will be even more powerful if, when writing, we cc (copy) parliamentary members of the opposition parties. (Peter Julian has been recently appointed NDP Finance critic and welcomes being copied on your emails and letters: peter.julian@parl.gc.ca. Pierre Poilievre is Finance critic for the Conservative official opposition party: pierre.poilievre@parl.gc.ca. David Hachey is the Green Party's Finance critic: david.hachey@greenparty.ca. And, of course, Minister Bill Morneau is the Liberal MP responsible for Finance: bill.morneau@canada.ca). Let them know we're concerned! If we wish to have Bill C-27 withdrawn, we need to let all of our Members of Parliament know that on behalf of all working and retired Canadians, we oppose Bill C-27.

What You Can Do Today

Make your views known – tell your member of parliament you want your pension security to remain intact.
