

## CORTA Annual General Meeting Monday, June 4<sup>th</sup>, 2018 Luncheon @ Coast Capri Hotel 11:30-1:20 pm

There were 28 members present at our AGM luncheon meeting. The meeting was called to order @ 11:55 am. A moment of silence was observed prior to lunch service. Rolli reminded luncheon goers that this was our Annual General Meeting and that first year membership in CORTA & BCRTA is free. A package will be sent out on behalf of CORTA to new retirees prior to the end of June. We paused to eat lunch.

Following lunch, the meeting proceeded. Tickets were sold for a 50/50 draw to support the CORTA bursary Fund. The bursary received \$100.00 and the winner's share was \$50.00. The winner was Steve Rees. Other door prizes, donated by Sandhill Wines and Interior Savings Credit Union, were distributed to CORTA members in attendance. -one-to-one support is available to those interested in all types of literacy development (speaking, writing, digital literacy). Support is available for all ages including students in elementary school, English Language Learners and seniors. Project Literacy Kelowna currently have 100 active matches.

Heritage Classroom- Sig Ottenbriett informed those in attendance that the Heritage Classroom @ Central School Programs on Richter Street will be open for tours this week on Thursday, June 7<sup>th</sup> at 1 pm.

Prior to the adjournment of our meeting, a second brief presentation was made.

Chandel Schmidt, JoeAnna's House (<u>https://www.kghfoundation.com/joeannas-house/</u>)
-spoke about the services KGH offers to the Interior region (1 out of 4 patients is from outside the Kelowna area)

-housing can be a challenge for families when patients remain in hospital for long periods of time -JoeAnna's House (named for major contributors, Joe and Anna Huber of Prestige Hotels) will help address this concern with 20 bedrooms to be constructed in the facility (along with mainfloor shared spaces- livingroom, kitchen, exercise room, day use area and laundry facilities). Unlike Ronald McDonald Houses, JoeAnna's House will accommodate families of patients of all ages, not just children. A nominal fee will likely be charged to those accessing JoeAnna's House (however, this fee can be waived if needed)

-JoeAnna's House will be built at the corner of Abbott & Richter (land is a long term lease from KGH) -donations invited (\$5.3M already raised, construction starts in September 2018 with completion expected September 2019

-a pamphlet was provided
