# Excerpts from our guest speaker's material:

### **Building an Affordable B.C.**

Taxing speculation and investing in our neighborhoods to solve the housing affordability crisis.

# The Problem

B.C. is one of the most expensive places in the world to live, particularly in the Metro Vancouver area. Fewer working families and individuals are able to purchase a home than ever before. Homelessness is growing more widespread and increasingly severe. Even those with good jobs and stable incomes are now finding it difficult to rent, many are forced to leave the area making it difficult for employers to fill vacancies. Seniors on a fixed income are more vulnerable to price increases; many are already spending more than 30% of their income on housing.

# The Cause

The principal reasons for persistent and longstanding growth of real estate prices in B.C. (and in Metro Vancouver especially) are various. They include:

- Desirability of B.C. and Metro Vancouver as locations
- Population growth
- Increased speculation
- Sustained low interest rates
- Larger real estate loans by financial institutions

- Outdated zoning and land-use policies
- Foreign Investment
- Speculative Value Vs. Productive Value

The more troubling, underlying cause of our situation, however, is that housing and property is being treated primarily as a financial asset rather than a place to live.

### The Plan

Our vision rests on the assumption that being able to rent or own appropriate housing is a basic condition of the social contract for working people in a democracy. In the absence of a stable and fair-paying job, or faced with other adverse circumstances, we also hold that ours is a society where those who need help finding a safe and supportive place to live will be provided that publicly.

With these simple guiding principles in mind, we think that a meaningful plan for addressing B.C.'s housing affordability crisis requires the following:

- 1. Reducing speculation and harmful profit seeking.
- 2. Stabilizing prices and reaching a new market equilibrium.
- 3. Restoring fairness and equity.
- 4. Enhancing revenue and resources for public investment in affordable housing and infrastructure.
- 5. Broadening access to quality public and non-market housing.
- 6. Reducing economic risk posed by excessive lending, household debt and inflated prices.

While many of B.C.'s housing affordability problems are the result of poor policy choices, there are concrete actions local government can take right now to make things better.

- 1. The 30% formula to define affordable housing.
- 2. Rental zoning to increase and protect the supply of affordable rental housing.
- 3. Fast-track affordable construction.
- 4. The 50/50 model where all future private density increases should be matched with an equal increase in public density.
- 5. Development cost waivers that target incentives for affordable rental construction.
- 6. 10-year tax waivers for public and non-market affordable rental housing construction.
- 7. Build on public land
- 8. Land value capture using TransLink's existing powers to tax a portion of the significant land value increases in properties close to mass transit lines and other publicly funded infrastructure.

# **COSCO Health Committee Report--- October, 2018**

National Pensioners Federation Convention:

Several COSCO members attended the NPF Convention September 25-27 at the Hilton hotel in Regina. COSCO submitted a number of resolutions that passed with the exception of one --- a health committee resolution concerning seniors' health and safety in subsidized seniors' housing. This resolution triggered a lively debate among the attendees. Attendees also participated in 3 workshops: pensions, national pharmacare, and seniors housing. I facilitated the pharmacare workshop and also gave an annual report on the work of the NPF Health Committee. Jerry Gosling presented on the Deprescribing Network. Trish McAuliffe was elected President of NPF. Pat Brady of COSCO was elected 3<sup>rd</sup> Vice president and I was elected member at large.

# B.C. Health Coalition:

The bargaining for a new contract with BCHC staff continues but It looks like the agreement will be signed very soon. A new staff member, Nadine Nakagawa, has been recruited (to replace Nat) and will start work at BCHC on October 12. She is one of 4 exceptionally well-qualified candidates interviewed for the position. She worked as a constituency assistant for Minister Darcy.

Bilateral agreements on Home Care and Mental Health:

COSCO received a letter mid September in response to a letter to Minister Dix asking whether B.C. has signed a bilateral agreement on the targeted home care and mental health funding. The letter said that B.C. has signed and that an announcement would be made shortly.

# COSCO Housing Committee report- October

Many thanks to Committee Members: Linda, Roz, Agnes, Charan, Barb

Actions during the last year: the committee worked together on five resolutions which were presented to COSCO in the spring, debated, updated, and passed.

These resolutions will go to the National Pensioners Federation in Regina in the fall. Issues include:

1. Implement 'Annual portable renters' rebate program', under the National Housing Strategy.

2. Address homelessness including 'Temporary Housing Programs', using structures which are not currently needed for housing.

3. Encourage 'land trust and lease extensions' to help co-ops which have their leases expiring.

4. Create 'Homeowners Expense Deferral Account' for a catastrophic cost, such as a roof or furnace repair.

5. Arrange 'rent banks' for tenants in crisis, to secure a tenancy and pay damage deposit, etc.

Roz spoke about 'Manufactured Homes issues' and her views had press coverage.

Improved policies are now implemented to give better compensation for Parks threatened with sale.

Roz and Leslie Gaudette spoke at the 'Rental Housing Task Force' and submitted a brief on behalf of the Langley Seniors Community Action Table about housing initiatives on 'mixed use' of housing.

Barb attended Health Minister Adrian Dix's announcements on health services and met Seniors Minister Anne Kang. MLA Kang invited COSCO representatives to her office to discuss issues, Barb attended.

Barb and Gudrun attended an open house invitation at 'Kaslo Modular Housing for Homeless persons'.

Housing Minister Selina Robinson announces 'Shelter Aid for Elderly Renters (SAFER)' funding increases, as well as the rent ceiling is raised for getting subsidy for rental costs beginning September, 2018.

Barb prepared the National Pensioners Federation report on national homelessness for their newsletter and AGM, as NPF Housing Chair. The powerpoint federal 'Housing Issues' presented to delegates there.

# Current issues:

-Issue of over 4% increase in rental costs stretches the budgets of people on fixed incomes.

-Increases in Home Adaptations for Independence HAFI, allowing secondary units in apartments.

-Relaxed zoning for additional density for housing.

-Affordability questions, repurposing housing stock, underused housing, building more modular housing.

-Consult First Nations about housing needs and timely responses on urgent issues.

# Housing

Last month the Delegates meeting had a suggestion of a letter from COSCO showing concern about the rent increase pending but this 4.5% increase is now under review by the Residential Tenancy Branch of the government of BC and their recommendation maximum rent increase is now the cost of inflation (2.5%) for 2019. Landlords are concerned that this rate will not give them enough for expenses of their properties, but some tenants find affordability is a serious concern. Housing will remain a hot topic coming into the elections of October 20<sup>th</sup>.

Nationally, Barb gave a powerpoint presentation on federal Housing Strategy updates for the National Pensioners Federation (NPF) at their convention in Regina in September. She continues as their Housing Chair.

# **Income Security Report to COSCO Executive October 2018**

We met on September 14<sup>th</sup>.

We decided to do a submission to the budget. However, we have less than 2 weeks to do it. Anyone who has a pressing issue, please send it to me.

We lightly touch on the Disability Tax Credit, hoping to make it a refundable one. We want to go forward with a meeting with the Finance Minister. The best times before Christmas are in the first 2 weeks of December. We need to discuss the topics and people who would make up the delegation as the Executive committee meeting. Our motion to NPF to raise the OAS to \$2,000 monthly passed.

# Submission by COSCO to the Provincial Budget

The Council of Senior Citizens' Organizations of BC (COSCO/BC) represents thousands of seniors throughout the province. We are a volunteer, non-profit organization and work to secure fair and equal treatment for all seniors in the province. Specifically we work in the areas of health care (including home support and Pharmacare), housing, transportation and income security. We are happy for the opportunity to express our position on Budget 2019 for British Columbia.

Seniors account for more than 20% of the population in BC, the majority being women. Women are twice as likely as men to live alone. Poverty is a serious problem for many seniors, both men and women, and as the BC Seniors Advocate points out many are faced with untenable choices: pay rent or buy food; buy food or buy medications; buy food or pay heat and hydro.

We would like to propose the following to be included in Budget 2019.

1. Increase the Seniors Supplement that is currently \$49.30 a month and has not increased since 1989.

- 2. Adjust provincial social program criteria upward to take into account indexes to federal pensions. Presently seniors have these increased amounts clawed back from provincial programs.
- 3. Provide more subsidized housing where renters pay no more than 30% of their gross income as rent.
- 4. Attach rent increases to the unit, not the renter.
- 5. Match SAFER grants to the amount of rent increases (2.5% in the coming year).
- 6. Create a plan for home owners facing catastrophic repairs (furnaces, roofs, windows). The plan could be modeled after the Property tax deferral plan, whereby low-income seniors could borrow money for their home repairs and pay it back upon sale of the house. Fund this plan.
- 7. Ensure that people being evicted from Manufactured homes receive fair and equitable compensation for their units.
- 8. Roll the cost of the medical examination of drivers in their 80s into the MSP. To be forced to pay for these checkups is discriminatory.
- 9. Expand the low-income bus pass to include any senior earning less than \$25,000 per year.
- 10. Expand the Pharmacare program to include eyewear, hearing aids, mobility devices and dental care.
- 11. Make home support and home care free of charge to seniors earning less than \$25,000.
- 12. Enhance nutritional support programs for seniors.
- 13. Support 'rent banks' for those who need to borrow to pay their rent. Include the speed of access in this request as many seniors have immediate needs.
- 14. Regulate and fund adequate staff to implement and enforce new (and old) regulations around housing.
- 15. Provide core funding for independent community-based senior centres that offer multicultural programs. And provide subsidies for a regular meal program at these centres.
- 16. Provide seniors centres with the infrastructure and resources for Information and Referral programs so that seniors get help navigating the requirements for access to programs.

# **COSCO** resolutions to the convention:

Carried as written:

RENT BANKS – That the National Pensioners Federation urge the Federal government to work with provincial and municipal governments to set up "Rent Banks" for renters in crisis.

ANNUAL RENTERS' REBATE PROGRAM – That the National Pensioners Federation urge the Federal government to ensure the speedy implementation of the National Housing Strategy portable annual renters' rebate program.

COOP HOUSING SUPPORT – That the National Pensioners Federation encourage the federal government to offer land trust or lease extensions to help co-ops invest in rehabilitation and maintenance of aging structures and construction of new ones. BILL C-27 INCOME SECURITY – That the National Pensioners Federation call on the Government of Canada to withdraw Bill C-27, and Act to ament the Pension Benefit Standards Act, 1985.

OLD AGE SECURITY (OAS) – That the National Pensioners Federation call on the federal government to increase the Old Age Security to \$2,000 a month.

# Carried as amended:

TEMPORARY HOUSING PROGRAMS – That the National Pensioners Federation urge the federal/provincial/<u>territorial</u> governments to conduct research and share findings on successful models for addressing homelessness among seniors, including Temporary Housing Programs in the transition back to permanent housing.

EXPENSE DEFERRAL ACCOUNT – That the National Pensioners Federation urge the federal government to set aside funds to create a Homeowners Expense Deferral Account program to allow senior homeowners with low costs such as repairs to a roof or furnace, and that the deferred amount becomes due upon the sale of the property, death, or voluntary repayment, and that total deferments be allowed up to 75% of the equity of their home and be charged simple interest.

Joined with BC Forum resolution:

BANKRUPTCY PROTECTION – That the National Pensioners Federation call on the Government of Canada to fix bankruptcy laws so our employee's pension and health benefits are given the same priority as secured creditors to stop employers from putting shareholders, banks, and creditors ahead of their employees when they file for bankruptcy protection.

### Referred back to COSCO:

IMPACT ON SENIORS OF MIXED TENANCY HOUSING –That the National Pensioners Federation urge the Federal/Provincial/Territorial Governments to provide rent-gearedto-income housing dedicated for seniors as part of affordable housing strategies and not allocate suites in the same building for tenants who may have serious behavioural issues. Defeated:

NPF COMMITTEE CHAIR SUPPORT – That the National Pensioners Federation (NPF) Committee chairs that are giving committee reports attend the NPF Convention at NPF expense.
