





East Langley Schools — A Personal Connection

Although much of the following information can be found in 'History of Langley Schools', a collaborative document compiled by Maureen Pepin, Norm Sherritt, and Harry McTaggart (all of whom were LRTA members), Seeing it through a pioneer's family's descendant's eyes would be interesting.

I recently received some documents from Fran Bolton (née McKay) whose family had a close connection with the schools in the East Langley area. She provided me with the following timeline, starting with the McKay twins, Angus (her uncle) and Neil (her father) who 'snuck' into the school system at the age of 4! She stated that, "Education was very important to the very early pioneers. They wanted an education for their families and worked hard to achieve this by donating land and volunteering their time for this precious concept".

The first East Langley School was approved by the province on May 28,1885 but was not built until the early settlers built the wooden building on W. James Davey's land, on the northwest corner of County Line Road (264th Street) adjoining the Fraser River. The school opened in January 1890. The 1890 Annual School Report-Volume 19-page 191 stated that Miss Calista Worth was the teacher until June 1890. When the school was inspected on April 11,1890, there were 7 boys ,6 girls (13). By June 30,1890 the attendance records showed 9 boys and 7 girls (16). Twins Angus and Neil McKay were admitted after the April inspection. Although the attendance form stated the twins were 6 by June 28,1890, they were not even 5 until June 7,1890. The Report in 1890-1891 stated that Miss Annie Creelman was the teacher. Miss Creelman would become the first full year teacher of Angus and Neil McKay.In 1892, a new East Langley school was built on an acre on the high bluff of 80th Avenue. Mrs. Calista GIBSON (formerly Miss Worth) was hired in August 1892 until June

30,1893. This new school, (according to B.C. Annual School Report-Volume 22-1892-1893), was inspected in October 1892 (20 pupils). In August 1893, Kate McKenzie was appointed the teacher until June 30,1894 (27 pupils). In August 1894-1895, William Smeeton was the teacher (23 pupils). Apparently, this school closed in 1924.

There was a new school-**Beaver School**- built on the Skea property at Coghlan Road (256th) and Roberts Road (56th Ave.). The first teacher, when the school opened in Jan. 1893, was Miss C. Shortreed. Some other teachers at Beaver School were Miss Carter (1907), Miss Bessie Green (1914-1916), Miss Ruth Hector (Mrs. Jim Skea) from Sept. 1916-June 1918. The Beaver School closed June 1918.

The first Glen Valley School was built in 1893 on half an acre of Gilbert McKay's land on Jackman Road (272nd) north of River Road (88thAve.). It was a wooden building 20 feet X 34 feet. The school opened January 1894 according to the B. C. Public School-23-24 Annual Report, 1893-1894. Mrs. A. J. McLellan was appointed in January 1894 as the teacher. Then the Report stated Mrs. A. J. McLennan was appointed from Jan. 1894-Sept.30,1894. When the school was inspected in April 1894, it had 3 boys and one girl in attendance. By June 1894, there were 9 boys and 11 girls. The official days for Jan. 1894 to June 1894 were short as the Great Flood of 1894 occurred. In October 1894, Miss Emily Parkinson was hired to teach at Glen Valley School. On inspection day on April 22,1895, there were 5 boys and 12 girls. By June end there were 9 boys and 16 girls. Mrs. Parkinson was still the teacher in June 1899 as she signed **Angus McKay's** Roll of Honor for Deportment.

When the Glen Valley School was inspected on January 22,1901, Miss J. F. Harrison was the teacher. There were 10 pupils under 6 at the time. When **Angus McKay** won the Proficiency Award in June 1901, Miss Harrison signed it. In 1901, **Neil McKay** completed the Central Examinations. Miss J. Harrison was the teacher 1901-1902. The inspection on February 18th, 1902, listed 16 pupils. A **new Glen Valley School** was opened in 1924 on land donated by John Cornock. This school existed until 1935. After that, the children went to **Fort Langley School**.
