# **Treasurer's Report**

I have just deposited the annual dues from the BCTRTA, bringing our cash on hand to \$10,371. Normally this would take us comfortably to the end of June, which is our year end. Due to Covid-19, the situation is complicated. We have too much money!

Too much money for a nonprofit that is not permitted to donate to anything is as much a problem as not enough money. The situation directly affects the mothership, BCRTA, because Canada Revenue Agency considers all branch money to be BCRTA money, also a nonprofit is not permitted to donate to anything. Presumably CRA is setting up protocols to allow for a temporary blip.

At this point I have to say thank you for continuing your membership. Our activities are curtailed, but our very existence as a part of an organized membership that communicates, observes, lobbies for and supports seniors and education is of great value and must not suffer loss of membership.

That value, this newsletter, Sunshine, scholarships (separate entity for tax purposes and with no access to our funds) are the only Covid-safe enterprises we have been able to continue for now. Of course many of you, our individual members, have continued or joined outreach to provide support to foodbanks, toy drives etc., but these are not, and cannot be, official RRTA activities. There must be many contributions that I haven't mentioned, and I appreciatively apologize. So thanks to you for your considerable contributions.

Your ideas for spending some extra cash may be helpful. If it requires a significant new workload for us, please consider helping. If it needs storage, please consider helping. We struggle every year with budget and suitable expenditures. Member benefit is really the only justification permitted. At this point, we can offer a greater subsidy to the luncheons when they start up. Again, the difficulty is of reaching all members and not just those able to attend luncheons and speaker events.

In the first week of July, Loraine was contacted by Umur Olcay, Manager of Facilities Planning for SD38, letting us know that General Currie's large portable would be the new home for the District Early Learning Centre. Consequently, the ELL classes were moving to Sea Island and the General Currie Heritage Building would now be home to the school's music teacher from Monday to Thursday.

#### Report by Bob Jackson & Lynne Farquharson for the 2020 BCRTA Conference and Annual General Meeting October 2nd, & 3rd, 2020

#### Preamble

The 2020 BCRTA Annual Conference and the 75<sup>th</sup> BCRTA Annual General Meeting was a virtual meeting held on zoom. It was hard to tell the actual number of delegates for you don't see everyone. The BCRTA had hired some extra information technology specialist to assist with both meetings. This also included a secure method for casting ballots to vote at the AGM. As a delegate for many years, I missed the opportunity of socialization with other delegates. One could send an individual chat message to a friend as the meeting was in session. I feel this format was successful for both the Friday Conference and the Saturday AGM.

#### Friday, October 2nd - 8:45 a.m.

The meeting commenced with introductions, review of the virtual meeting procedures and comments from the BCRTA President, Gerry Tiede, a former RSB employee.

#### Speaker #1 - Isobel Mackenzie - Seniors Advocate for B.C. - 9:00 a.m.

560 LTC and AL sites (40,000 people) under Provincial Health Officer (PHO) orders 55 facilities experienced 62 outbreaks (56 LTC and 6AL)

- 38 had no deaths
- 27 were contained to a single staff member
- 7 were contained to a single resident
- 6 were contained to 2 5 residents/staff
- 11 involved between 6 15 residents/staff
- 11 involved more than 15 residents/staff

This session was an excellent and informative presentation that highlighted the effects of the pandemic on seniors and the best practices into the future that is relevant to seniors. She indicated that "one size does not fit all" and that in BC we should work toward a "relationship model" rather than the current "medical model."

## <u>Speaker #2 – Dr. Steve Morgan – School of Population & Public Health – UBC - 10:30 a.m.</u> <u>Topic – Universal Pharmacare</u>

- Every high-income country with universal health care system provides universal coverage of prescription drugs, except Canada.
- There are more than 100 different public drug plans in Canada and thousands of different private drug plans.
- 1 year of generic atorvastatin (Lipitor) \$64 in Canada and \$9 in New Zealand
- 1 year of generic sertraline (Zoloft) \$110 in Canada and \$9 in New Zealand
- Our patchwork system provides worse access at higher overall cost, with greater financial risks, and attracts less investment from Pharma companies than universal public pharmacare systems do.
- Pharmacare saves Canadians more than it costs to implement, so it is **not** pharmacare or other health care, it is pharmacare and other reforms.

This was an excellent presentation. Universal Pharmacare in Canada would actually save the government \$\$\$. This presentation is available on the following URL.
