



President's Report cont'd

Your Executive and Directors will be meeting in the fall to plan for 2018/19. More information to follow.

Joint Survey Results (SRTA only)

- 26 of 966 members (2.7%) participated in the survey
- Average length of retirement for the respondents: 11 years
- 62% of the respondents live in Surrey/White Rock
- 91% described the pre-retirement workshops as helpful
- 57% said they were adequately informed about medical coverage
- Several members questioned the move from Pacific Blue Cross to Green Shield
- 67% said they were adequately informed about dental coverage
- Some members expressed dismay, frustration, etc. with the current provider
- 52% said they did not know about Prestige/Medoc benefits (with some members requesting information on these benefits)
- 71% said they knew about BCRTA's Advantage Program
- 71% also said they would like more opportunities to socialize with other retired teachers

• Suggestions for local area day trips included:

- Walking or hiking with a guide/naturalist;
- Shopping trips to Bellingham;
- Trips to wineries, plays and casinos; and
- Trips to local tourist destinations including Capilano Suspension Bridge and Steveston.

Suggested topics for future workshops included:

- Health & Wellness;
- Pension Plan;
- Financial Planning;
- Downsizing;
- Assisted Living;
- Preparing a Last Will & Testament; and
- Technology (computers, tablets, smartphones, etc.).
- Aside, one respondent described the continuing education opportunities offered by post-secondary institutions as excellent.
- Two respondents encouraged us to continue to publish information on volunteer opportunities.
- Further aside, two respondents called for greater advocacy for medical benefits and care facilities for the elderly.
- Preferred meeting locations by percentage of votes cast:
- Central Surrey 40%
- Cloverdale 23%
- Langley 20%
- Delta 17%
- Preferred meeting time: Afternoons (1:00 to 3:00)

President's Report cont'd

Dear --, MP:

As Canadian citizens, we want stable and reliable pension plans. They are good for us, good for our society, and good for our country's economy. We know that the ideal pension plan is one with risk shared equally between employers and employees, with oversight by a board composed of active work, employer and retiree representatives. Such a plan is like the one you yourself enjoy – a defined benefit pension plan.

However, we have Bill C-27. It has been introduced in the House, it has had first reading, and it threatens defined benefit pension plans in Canada. It enables the conversion of defined benefit plans to target benefit plans, jeopardizing the retirement income security of workers and retirees, who have negotiated pensions as a form of deferred wages. The text of the Bill includes 14 references to secure pension benefits being "surrendered" by workers and retirees!

The Federal government pledged to improve the well-being of the middle class. But, rather than ensuring the pension security of all Canadians, it has introduced this bill, which removes responsibility from employers, which transfers all risk of financial market volatility to workers and retirees, and which clearly threatens the security and predictability offered by defined benefit pension plans.

We are fiercely opposed to Bill C-27. It allows employers to simply abandon their commitments and walk away from their pension obligations. We call upon the government to withdraw Bill C-27.

We are mounting a campaign across our province. It will ask our Members of Parliament, in petitions originating across British Columbia, to voice our objection to Bill C-27.

We ask that as our MP, you commit to introducing our issue to the House so that we may voice our opposition to Bill C-27. We shall be calling you in the next little while to set up an appointment to discuss our petition. We will be asking you then whether you will read out our petition to Parliament.

Update on Bill C-27

We collected signatures at the Annual General Meeting in May, at "To Hell with the Bell" in September and at the Surrey Teachers' Association office from September 17 to 21.


The good news is we've collected 98 signatures to date. The not so good news is we have not yet collected the minimum 25 signatures for any of our five MP's.

I contacted the organizers a few days ago. They were empathetic. They told me that while the deadline was September 22, it would be better to submit our petitions late than not at all.

I also emailed the Executive to update them on our progress and to suggest that we invite attendees at the upcoming luncheons and workshops to sign one of the petitions (if they have not done so already).

Bottom line, I remain confident that we will secure the minimum 125 signatures (5 MP's * the minimum 25 signatures) early this Fall and that collectively, we will join the many others opposing Bill C-27.

Heritage School Finds A New Home

With the goal of preserving one of Surrey's valued historical buildings, in the early morning of Sept. 7, the Anniedale pioneer school was moved from its location at 176th Street and Highway 1 to its new home on the grounds of the Surrey Museum in Cloverdale. The old school is slated to become a significant part of the museum's programming and will enable presentations of 19th Century school lessons in a historical context. This will be a unique opportunity for children to 'experience' being pioneer students. The preservation of this heritage school was thanks to the untiring efforts of countless volunteers and community groups.
