#### **President's report**

On April 4<sup>th</sup> there was standing room only at our General Meeting. Gerry Tiede, BCRTA First Vice- President and Chair of our Pensions and Benefits Committee, and Lisa Hansen, Johnson Insurance Representative, presented updates and answered many questions.

Gerry reported that our pension fund has been very well managed and we can look forward to future cost of living adjustments via the Inflation Adjustment Account. It was therefore most surprising to read Vaughn Palmer's comments in the May 9<sup>th</sup> edition of the Vancouver Sun. He stated that, "Only the teachers' pension plan lagged, with assets matching only 97 per cent of obligations, a shortfall of \$372 million. As the plan is joint trusteed, the liability is shared equally between teachers and provincial taxpayers, needing a top up from both." In fact, Mr. Palmer used data that does not describe the current state of TPP assets. When asked, Gerry Tiede responded that Vaughn Palmer is just plain wrong. Dale Lauber, BCRTA Representative on the Pension Corporation Board of Directors, responded that, "the pension plan had a valuation in 2014 and that showed a surplus in the pension plan of 102% funded. There will be another valuation as of 2017 and the pension board is confident there will be even a bigger surplus. Looking forward to the next valuation that will be in 2020, there is every reason to believe that there will even be a surplus at that time. The pension board is confident that there will be a contribution reduction for members and employers at the 2017 valuation."

At our February General Meeting, attendees signed the CRTA's petition to **Withdraw Bill C-27** and Howard Spence subsequently delivered it to MP Fin Donnelly. Mr. Donnelly presented our petition in the House of Commons on April 18, 2018. Congratulations to CRTA members for taking action on this important issue! We believe that if Bill C-27 passes there will be huge pressures on all defined benefit plans to convert to target benefit plans because corporations and governments can get out of their future responsibilities with TB plans. In fact, if employers are encouraged to convert defined benefit provisions they currently receive.
