Treasurer's Report – submitted by Howard Spence:



Your executive managed your finances very well, keeping all items close to our budget. We had decided to run a small deficit, our first ever, in keeping with BCRTA's requirement that income be spent on member benefits, and that all branches combined, along with the BCRTA finances, would not show a significant profit, in order to retain our not-for-profit status. So we subsidized all 3 lunches and increased door prize values, anticipating a deficit of about \$500. All told, with lunch subsidies totaling about \$1300, and door prize values about \$600, and with other expenses close to last year's, we ended the year with a deficit of \$140.

We will set our budget for the coming year at our next executive meeting, likely with roughly the same expenses and revenues. More details will follow as the year progresses.
