A Brief Financial Update







Your association ended its financial year on June 30 with a healthy balance sheet. Our year-end balance was \$4,365, a net deficit of \$114. Using member fees for the benefit of members is a top priority, so we devote our financial resources mainly to meetings, lunches and our regular newsletters. For the coming year, we have budgeted for a deficit of about \$300, in an effort to balance out surpluses over several previous years. Once that has been achieved, we will strive for balanced budgets.



Bill C-27 continues to pose potentially serious threats to the sustainability of pension plans. Bill C-27 will allow plan sponsors to reduce future pensions, even for pensioners already retired. As you will recall, CRTA members signed two petitions asking the federal government to withdraw Bill C-27. MP Fin Donnelly (Port Moody- Coquitlam) presented the first petition in the House of Commons but MP Ron McKinnon (Coquitlam- Port Coquitlam) refused to present the second. However, as we go to press, MP Peter Julian (New Westminster-Burnaby) has agreed to present the second petition in the House on behalf of the CRTA members who signed it.
