- You may get phone calls, emails and texts on COVID-19. Be cautious when receiving them:
- remember that if you didn't initiate contact with a person or a business, you don't know who you are dealing with
- never click on links or attachments in unsolicited or suspicious emails
- never give out your personal or financial information by email or text
- note that financial institutions will never ask you to provide personal, login or account information by text or email
- when banking online, enter your financial institution's website address in your browser yourself
- beware of questionable cures for sale: if it seems too good to be true, it probably is

Sad to say (pun intended), grief isn't anyone's favourite topic. Motivational speaking is usually about inspiring people, pumping them up and helping them move (hurry) forward.

Loss slams the brakes on and insists on being acknowledged. Negative emotions don't decompose —they often move sideways in our lives and pop up uninvited at the least opportune time.

How do we make sense of loss, cope with our grief and find renewed meaning in life when all we want is to curl up and turn off the world?

How do we endure through circumstances over which we have no control (you know, little things like pandemics!) but which we desperately wish were history?

Why not spend a morning with me, pondering these weightier topics? After all, everyone hurts. And everyone craves connection. And though we all want a quick fix, we also know that none exists. Let's talk about it, shall we?

#### Workshop Presenter: Clair Jantzen

Clair holds a Master's Degree in Clinical Counselling and is a Registered Professional Counsellor with the Canadian Professional Counsellors Association. He has also completed advanced training and is certified as a Support Group Facilitator with the Grief Recovery Institute.

He has over 40 years experience in counselling, support group facilitating and workshop presenting. From 1998 to 2019, he was employed at Springfield Funeral Home in Kelowna as grief counsellor, celebrant and funeral director. He is now a private practice grief and loss, marriage and family therapist. In addition, he provides

supervision for those seeking accreditation with the CPCA.

He is a published author of Tears in a Bottle – Stories of Life and Loss, Trafford 2012 and "Living with Grief: Children and Adolescents, the Value of the Funeral and Viewing."

Clair has been a guest lecturer at UBC Okanagan in the gerontology, social work and nursing departments, Okanagan College and other local private colleges. He has been an instructor for The Canadian College of Funeral Services for 8 years, teaching The Psychology of Death, Dying and Disposition.

He is a community instructor to schools,



businesses and groups such as the Interior Alzheimer Society, Interior Health, BC Cancer Agency. He has been involved in "grief debriefing experiences" for caregivers in health care facilities, including the Pursuit of Excellence Hockey Academy in Kelowna following the Humboldt tragedy.

He is passionate about caring for people, hoping to provide them with the necessary understanding and context for their life and its challenges.

Personally, he is married to Rachel (36 years), has a married son who just graduated from UBCO Engineering and a married daughter in West Kelowna. She and her husband have made him a proud Grandpa. (He'll show you pictures!) f

## Application for Teacher Liaison at Learning Buddies Network

Have you recently retired from being an elementary school teacher and are feeling at loose ends? Are you missing contact with: young students; the school community; the classroom; a sense of fulfillment in your retirement?

Learning Buddies needs you!

Learning Buddies Network (LBN) is a local non-profit organization founded by a paediatrician, Dr. Alisa Lipson, in 2008 to support young students who are behind grade level in reading and math.

LBN provides free one-toone tutoring at 8 school sites (Vancouver, Richmond, Burnaby and Surrey).



Empowering Kids through Reading & Math.

Our mentors are volunteer high school students and/or university students who are recruited and trained by LBN.

In response to the onset of the Covid-19, epidemic, we developed a successful on-line program delivered by Zoom sessions twice a week. Each online Pod has a volunteer student as Executive Coordinator and Program Coordinator who support 8 mentor/buddy

pairs.

We are currently searching for a retired or part-time elementary teacher who would support our organization in a paid position for approximately 6 hour per week plus some variable meetings, as the School Liaison (when on site) or the Pod Liaison (while on zoom).

Duties include, being present

for the duration of a twice weekly session, moving among each mentor /buddy pair to assist with teaching strategies that the mentor or buddy may be struggling with, provide help when buddy is distracted, offer positive suggestions to make the session more efficient,

Some recipients (our 'buddies') are identified by teachers as discouraged elementary students who struggle with basic reading and math skills. Other recipients are identified by parents who have responded via the LBN website. model effective ways to ask comprehension questions, teach new vocabulary, or develop a phonics skill.

You will also provide positive and constructive feedback to mentors during the closing part of the session. In general, as Teacher Liaison, you provide professional support to mentors and buddies alike.

The successful candidate will report to and collaborate with the Operations Manager as well as the Head

Teacher Liaison. A full job description and remuneration details can be provided upon request.

## Learning Buddies Network Board Member Recruitment Post

#### Organization Description

The Learning Buddies Network (LBN) inspires a love of learning, one child at a time. The goals of the organization are:

- 1. To provide free extracurricular mentoring to elementary school children who are struggling with basic academics;
- 2. To improve academic skills, self-esteem and attitude to learning in these children through teaching, one-on-one mentoring, and group activities;
- To provide young adults a meaningful and rewarding volunteer experience with an opportunity to act as a role model to children and develop leadership and communication skills.

Our usual model is to provide mentoring sessions weekly in group sessions in schools. Currently with Covid, we are providing reading twice a week online, and will soon roll out our online math program. We currently serve 150 child/mentor pairs.

About the Board: The Board is made up of volunteers who are teachers, principals, doctors, lawyers, accountants, and former volunteers and staff of LBN. As our principals' terms end this spring, we are seeking new board members.

Skills: We are looking for individuals who are current or retired educators, ideally with some experience and knowledge of elementary level reading and math curriculum. Past work with children with learning challenges, and also experience in the BC school system would be assets.

Term: Elected Directors are renewed annually although candidates are preferred who are willing to commit to a minimum 2-to-3-year term.

Time Commitment: The Board meets together every two months with committee meetings more frequently.

## The BCRTA Is Proud To Celebrate Its 75th Anniversary!

## Happy 30Th Anniversary To The Surrey Retired Teachers' Association!



After the BC Teachers' Federation was formed in 1917, retired teachers began meeting in private homes in Vancouver, and they formed themselves into an association with the primary purpose of improving teachers' pensions. At about the same time a group of retired teachers in Victoria formed an association with the same goal. Eventually the two groups joined in common purpose, which led to the formation in 1945 of the BCRTA. The B.C. Retired Teachers' Association was incorporated as a Society in 1955 with its main objective "to guard the interests and to promote the welfare of its members." At that time the Association had about 1,100 members and Mr. R.R. Smith was president. Over time, branches of the the provincial body formed throughout the province.

The SRTA is also celebrating its 30th Anniversary. To mark this milestone, the Heritage Committee is working on a publication called "Snapshots" consisting of memories of the Surrey School District. SRTA members and others have contributed to it. Watch for it online in the next couple of months.
