### **PENSION UPDATE: GOOD NEWS!**

Here is the latest news from the Teachers' Pension Plan. Fund returns for the year 2020 came in at 10.5%. Annual returns from March 31, 2020 to March 31, 2021 were estimated to be between 16% and 17%. Our 5 year average is 8.1%, about of the 6% require

16% and 17%. Our 5-year average is 8.1%, ahead of the 6% required for our pensions to be fully funded. So the news at this time is outstanding, especially considering all the uncertainties of the past year.

Of course, this can give rise to pension envy, with folks complaining that we are living high on taxpayer dollars. Just remind them that your pension is based on **your** contributions over the years, including employer contributions made in lieu of higher salaries. Your pension is also funded in great part by investment returns, and we are all so fortunate to have a pension plan which is so well managed. Of that, others can rightly be envious!
