

# Volun-Tourism: Exploring Albert Frey's Legacy

latest volun-tourism I had the privilege of the architectural marvels Springs, California. Last

week, the desert community showcased its 'Modernism' theme, offering tours of some unique mid-century homes. I volunteered to help lead tours of the Frey House and was thrilled to showcase the work of Swiss architect Albert Frey. Frey first visited Palm Springs in the 1930s and fell in love with the mountains, reminiscent of the Swiss Alps of his homeland. After a year of hiking the San Jacinto mountains, he discovered the perfect spot for his home. While



most architects seek level ground, Frey was ambitious and innovative. His stunning structure, Frey House II, is perched precariously on a steep rock face, 300 feet above the bustling downtown Palm Springs strip.

Though I don't consider myself an expert in mid-century architecture, my passion for learning makes me feel like an imposter sometimes. Albert Frey, born in Zurich, Switzerland in 1903, moved to Palm Springs in the mid-1930s. He is renowned for

projects like the Aerial Tram, Tramway Gas Station, Aluminaire House, Palm Springs City Hall, and Desert Hospital. The tour I helped lead was both exhilarating and challenging, taking place in 103-degree temperatures on the distinctive rock outcropping of Frey's actual home. Together with a friend, it took two years to build this 900-square-foot residence, which Frey lived in until his passing in 1998 at the age of 95. His designs harmoniously blend with the surrounding landscape, and though the home is small, the many windows and crisp lines create a feeling of spaciousness.

Fortunately, I had prepared by learning about Frey, and I was paired with his godson, Marc, to lead the tours. Marc's parents were also from Switzerland, and his father worked closely with Albert, forming a deep bond. Marc spent much time in this home, and his stories added a personal touch to the tour. His father, a former circus acrobat, encouraged Marc's adventurous spirit—allowing him to climb the rock inside the house, play hide and seek, and later scale the outside rock and traverse the corrugated aluminum roof before cannonballing into the pool below.

The pool itself is unique, lacking stairs to exit. On the northern edge is a large bulge, which one can slide into the water from, anchored by a massive boulder underneath.

Marc shared many fascinating anecdotes about life with Albert, including how, when LEGO first debuted, young Marc bought one of the first sets as a Christmas gift for Albert. Another intriguing detail was the hidden safe near Albert's bed (which I found!), along with custom-made curtains that mirrored the springtime landscape, bright yellow like the blooming bottlebrush. Frey positioned his bed to face east, allowing him to gaze at the PSP airport, as he was an avid pilot. He referred to the sunrise as his "gentle alarm clock."

If you find yourself in Palm Springs, don't miss the chance to visit the Palm Springs Museum, which offers free admission on Thursday evenings during the street festival. Just down the road, the museum's annex features a full exhibit devoted to Albert Frey, showcasing his drawings, photos, and models. What a fascinating man! On Saturdays, you can book a guided tour of Frey House II, but be sure to reserve early, as it's a popular attraction. Or you can volunteer with Palm Springs Life and become a tour guide like I did! ### The Memorial Society of BC

The Memorial Society of BC (MSBC) is a registered nonprofit helping people access affordable and dignified cremations and burials since 1956.

The Memorial Society movement began in Canada in the 1920's as a response to rising funeral costs, with the goal to create informed prepared community members who have access to affordable funeral services. The non-denominational movement grew across North America so that now most provinces and states have Memorial Societies or Co-operatives. Since its inception, MSBC has had more than 250,000 members, and was recognized for its service to the province in 2008 with a BC Human Rights Coalition Award.

Members pay for a lifetime membership (under \$100 in total), which entitles them to a reduced price (typically 10-20%) on basic cremations or burials from our partners, who are independent and family-run funeral service providers from across the province.

Our member support team provides knowledgeable and compassionate support to members and their families, whether in preparation for, or after a death. Members also have access to an online account where they can store their vital statistics and arrangement information. Our website, social media and community presentations are great places to find information and to learn about your options.

As classes resumed at the start of 2025, many found ways to recognize the new year, such as this student-initiated New Year's Resolution Project at Burnaby North Secondary. Grade 4/5 students at Brentwood Park Elementary worked together to showcase their resolutions for 2025 through art. An intermediate class at Brentwood was among those who set goals at the start of the second term. A Grade 5/6 class at Buckingham Elementary wrote about what they want to accomplish this year. Students in dance from five high schools started the year off with a collaborative performance. The show featured the talents of dancers from Byrne Creek, Burnaby Central, Burnaby Mountain, Alpha, and Moscrop Secondary schools. Children at Suncrest Elementary have been testing out their recently installed sensory pathways in the hallway. It provides a fun brain break, with short activities to help students reset and refocus. Children at Second Street Community School returned from Winter Break to news that **Sophia** was being celebrated for winning a provincial contest. Her design was selected by Easter Seals BC/Yukon as one of two winners in their annual contest. Grade 6 to 12 students are challenged to symbolize a more "AccessAble society." Additionally, the design by Darrel from Byrne Creek Community School was chosen as a runner up. And as Lunar New Year approaches, many are getting ready for the Year of the Snake. These creations are by children at Forest Grove Elementary – home of the District's Mandarin Language Arts Program. #### SUPPORTING STUDENT PLANNING FOR NEXT FALL

Forest Grove's information evening about the Mandarin Language Arts Program was among many planning sessions held across the District – all designed to help students and their families make decisions for the 2025-26 school year. The Program of Choice is among the options at the elementary level. Families were also invited to an information session to learn about French Immersion.

Additionally, there are dozens of District Programs of Choice for students in high school.
