

Welcome to our monthly KTRTA Bulletin Newsletter!



News: BCRTA AGM: September 26-28 2024

Marney Bethell, Rose-Marie Stolze, and Troylana Manson attended the BC Retired Teachers Association's AGM Conference in Vancouver. These events give members across the province to interact, share concerns, and advocate for local, provincial and national issues affecting our members. As well as a new executive and committee members being selected/voted in for the coming year, keynotes speakers are carefully selected to share important information about 'common' or 'hot button' issues.

Gale Pirie presented about the complicated issues surrounding 'Estate Appraisals', David Falconer presented a powerful 'Classrooms Without Walls' session, which included a live feed of his students from Ukraine, China, and Afghanistan , and lastly, Hilde Deprez presented a very informative session on Notary Public's role for seniors planning.

Summary of David Falconer's Work and Story: Submitted by Rosemarie Stoltz

Background

- David Falconer grew up in Chile, where a coup disrupted his life in 1973. His mother helped him and his brother escape to Peru.

- He lived in the Amazon jungle, experiencing isolation but finding comfort in a supportive school community, which influenced his future as a teacher.

Current Work in War Zones

- Since 2022, David has been teaching students in war-torn regions, starting in Ukraine.

- He teaches GED prep, math, and science via Zoom, offering care and stability to children in difficult circumstances.

Expansion of Online Teaching



- David now reaches students in multiple countries facing war or gender restrictions, showing them that people care.

Colleague Contributions

- **Carol: Former math teacher from Chicago, now teaching math and GED prep to students in Ukraine and Myanmar.

- **Susan: Former teacher in Canada, now teaches Canadian history to Ukrainian students with interpreter assistance.

Student Experiences

- **Cat (Myanmar): Overcame fear and depression, now working towards her GED and co-authoring a book titled *Amazing Resilience*.

- **Sophie (Ukraine): Struggles with fear from violence and displacement, finds comfort in talking to teachers from stable regions.

- **Adela (Afghanistan): Lost her right to formal education but uses a friend's computer to attend Zoom classes, encouraging more teachers to volunteer.

This summary highlights the profound impact of David and his colleagues, who provide education, care, and emotional support to students in crisis regions.

Summary of BCRTA AGM & Speaker Gail Pirie on Estate Appraisals: Submitted by Marney Bethal

Key Highlights:

- The event offered valuable updates on topics like pensions, insurance, estate planning, and organizational resources.
- Johnson Insurance rebranded to Belaire Direct, with new options for stand-alone travel insurance.
- Attendees were reminded to share information on BCRTA's Golden Star Awards and to consider "warm hands" donations to minimize potential estate conflicts.
- Advice was given to review wills every seven years and to note the shift from living wills to Advance Directives.
- BCRTA resources are accessible via their Facebook, Instagram, and YouTube channels.

Gail Pirie, an appraiser and CBC's Antique Road Show contributor, spoke on handling collections, emphasizing the value factors of demand over age, rarity, or condition. Popular collectibles included Art Deco items, textiles, vinyl records, and jewelry, whereas dining room furniture and traditional dish sets have diminished in value. Pirie offered insights into appraisals and collectible market trends.



Summary of Hilde Duprez's Notary Public role for seniors: Submitted by Troylana Manson

Power of Attorney (POA)

- Grants legal authority to an agent to make decisions on behalf of a principal.
- Types:
 - *General: Broad financial and personal authority.
- *Limited: Restricted to specific tasks or time frames.
- *Durable: Remains valid if principal becomes incapacitated.
- *Medical: Authorizes healthcare decisions.
- Requirements: Principal must be of sound mind; the document must be signed and often notarized. POA can be revoked or modified at any time.

Healthcare Directive or Representative Agreement

- Appoints someone to make healthcare decisions if you're incapacitated.
 - ***Section 7**: Basic healthcare powers; includes advance directives with limited authority (e.g., non-life-ending decisions)
 - ***Section 9**: Enhanced powers; allows specific health care instructions, but does not mandate life-ending choices
 - *A **Living Will** serves as your voice for healthcare wishes, especially if you cannot make decisions due to disability or addiction. It does not authorize life-ending actions.

Wills

- Legal document specifying asset distribution and care for dependents after death.
- Executor: Manages distribution, communication with beneficiaries, and settling debts. Executors are usually compensated.

Considerations

- Age Requirement: Typically 19 or older.
- Blended Families: Important to clarify inheritance to avoid conflicts.
- Updates: Review every 7-10 years or after major life events.
