

### OCEANSIDE RETIRED EDUCATORS' SCHOLARSHIP (ORES)

Last year, we collected \$1700 for the Oceanside Retired Educators Scholarship (ORES) which provided scholarships to two local graduates from Qualicum School District. Both of these students were aspiring to become future educators.

This year, our target for the ORES fund is \$2500 to support the three local high schools:

- \$1000 to a Kwalikum Secondary graduate,
- \$1000 to a Ballenas Secondary graduate, and
- \$500 to a graduate from PASS (Parksville Alternate Secondary School)

Towards our goal of \$2500, we have collected \$1445, which is almost half way there.

Thank you to those people who have already donated. If you haven't already, you should soon receive your individual income tax receipt from the school district. However, we still require \$1055 to reach our goal to support the post-secondary education of three worthy students. Of course, this is our minimal expectation and more would be a wonderful addition for the students.

You'll be glad to know that due to the postal strike this past November and December, the income tax deadline for 2024 donations has been extended to February 28, 2025. Lucky us! You can still donate NOW and receive a 2024 income tax receipt for your 2025 tax return, but get it done soon.

The deadline for collection of ORES funds is **April 15<sup>th</sup>**. We hope that you will take the time to send a few dollars...even the price of a coffee, 'cuz little bits add up to big bits!

This April, the ORES committee will be looking at the student applications for ORES funds and we welcome your input. Please contact Cathy if you are interested in perusing the applications . You can do it on your own time and then meet the committee to help to make the decision of three worthy recipients.
